



THE MUNICIPALITY OF BIFROST-RIVERTON

BY-LAW NO. 2-2022

Being a by-law of The Municipality of Bifrost-Riverton to establish the indemnities and expenses for members of Council and repeal By-Law 11-2019.

WHEREAS Section 124(2) of *The Municipal Act* provides that, “a council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district,

- a) as compensation for attending to municipal business;
- b) for expenses incurred while attending to municipal business; and
- c) for any other purpose relating to municipal business that the council considers appropriate.”;

AND WHEREAS the Council of the Municipality deems it necessary to amend said rates of compensation for members of Council;

AND WHEREAS the Council deemed it expedient to amend and repeal By-law 11-2019;

NOW THEREFORE the Council of The Municipality of Bifrost-Riverton, in council duly assembled, hereby enacts as follows:

1. DEFINITIONS

- a) “Expense” means an expense incurred by a member of council or council committee in attending to municipal business, and includes automobile expenses or mileage, travel expenses, living expenses, registration and tuition fees, the costs of materials for a meeting, conference or course, out-of-pocket expenditures and any other expense provided for in a by-law;
- b) “Municipal Business” means a duty or function that a member of council or council committee is required to carry out under this or any other Act or a by-law or resolution, and includes attending a meeting, conference or course of instruction that relates to municipal purposes.

2. COMPENSATION OF REEVE

THAT the Reeve of the Municipality of Bifrost-Riverton shall receive compensation of \$12,670.00 annually for the discharge of duties as a member of Council, which shall be paid on a monthly basis in twelve equal installments.

3. COMPENSATION OF COUNCILLORS

THAT all other members of Council of the Municipality of Bifrost-Riverton shall receive compensation of \$9,210.00 annually for the discharge of duties as a member of Council, which shall be paid on a monthly basis in twelve equal installments.

4. COMPENSATION OF MEMBERS OF COUNCIL – ROAD COMMISSIONERS

THAT each member of Council of The Municipality of Bifrost-Riverton shall be paid travelling expenses and an indemnity for services rendered as Road Commissioners or any approved activities thereof, as follows:

- \$24.00 per hour; and
- \$0.59 per kilometer actually travelled.

5. COMPENSATION OF MEMBERS OF COUNCIL – MEETINGS

THAT each member of Council of The Municipality of Bifrost-Riverton shall be paid for attending meetings of committees or boards, for which the member has not received any remuneration, be paid their travelling expenses and living expenses together with an indemnity as follows:

- \$24.00 per hour; and
- \$0.59 per kilometer actually travelled.

6. COMPENSATION OF MEMBERS OF COUNCIL – TRAVEL BEYOND MUNICIPAL BOUNDARIES

THAT each member of Council duly authorized by resolution of Council to represent The Municipality beyond the limits of The Municipality of Bifrost-Riverton on the business thereof, be paid travelling expenses and living expenses together with an indemnity as follows:

- \$24.00 per hour; and
- \$0.59 per kilometer actually travelled.

7. THAT each member of Council shall receive a monthly communication allowance of \$75.00.

8. THAT this by-law shall become effective January 1, 2022.

9. THAT By-law 11-2019 is hereby repealed.


